### **Updates**

- Exec Business
  - The PDTA Executive Committee had discussion regarding the following topics: PDTA Exec and RA agendas and minutes, soliciting building news, Opening Day feedback, committee roster updates, and the PDTA Executive Committee Team.
- Central Office Several discussions took place regarding different departments in Central Office.
  - HR: Discussion in connection with the HR office included current investigations, the hiring process, overages/overloads, salary notices, an addendum to the Mandated Reporter Training, Global Compliance, the Workplace Violence Prevention Act, and SIRT teams.
  - Supt: Discussions in connection with the Superintendent's office included the Career Award date, reviewing the Reunification Process within buildings, heat mitigation, Bell to Bell Legislation, and Shana Cutaia joining the October RA meeting.
  - Special Education: Discussions in connection with the Special Education office included District
     Based Classroom Administrative Support, and obtaining CPI Training for SRPs.
  - <u>Technology:</u> Discussion in connection with the Technology office included potentially creating a Phishing Training, and the new Screen Lock Out Time with Windows 11.

#### PDAA:

- Stephanie had a summer meeting with each administrator. Her first meeting with PDAA is on September 15<sup>th</sup>.
- Sick Leave Bank Update
  - Contractual provision: all members of the Sick Leave Bank may elect to donate up to four (4)
     sick days to the Sick Leave Bank, each year, during the open enrollments period (October)
  - During the 24-25 school year, 170 days collected & 70 days donated (240 total added days).
     Additionally, 500 days were allocated in the 24-25 school year.
  - Currently, there are 453 days available at start of 25-26. Since we are at/below 500, we need to reassess at this time.
  - o Discussion are taking place about how to increase the number of days in the Sick Leave Bank.

• Para Workhours: All paras should have received communication of their workhours, and these should align with those communicated to payroll. If paras are unsure of their specific work hours, all paras are encourages to reach out to their administrator/supervisor.
