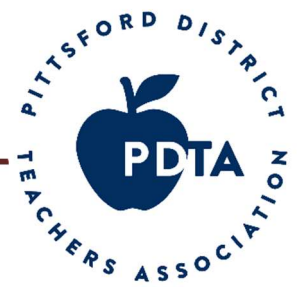


PDTA Executive Committee Meeting Minutes

- **Treasurer**

 - **The union has collaborated with HR to draft a comprehensive Posting information/guidance document that can be found on the PDTA website (pdta.org) in the Documents tab.**
 - **Some Common Interests:**
 - **Displaced: Must post and may post to multiple positions with a specified order or preference (recommended).**
 - **May post in multiple rounds until obtain preferred position.**
 - **PDTA recommends members share posting decisions with your building administrator as a courtesy prior to posting.**
 - **Only members who successfully post to a position will receive communication from HR. If you do not receive communication you can assume you did not obtain the desired position.**
 - **A protection has been secured for K-teachers/Paras who are in sections in jeopardy of collapsing and are impacted by the sectioning date changes. See your Building Rep for support if needed.**
