3. Sick Leave Bank:

RA Action established the Sick Leave Bank Advisory Committee: Executive committee has recommended the following breakdown for representation:

- 8-10 people: 1 certificated, 1 SRP from each level and 1 officer.
- It is recommended that the members of this committee come from RA due to a common knowledge base.

4. PDTA/HR – Reviewing Substitute Vacancy Processes:

PDTA / HR will be putting together a written document to send out. This document will be shared with SEAC to assist in covering vacancies.

5. Extra-Curricular:

Executive committee reviewed the extra-curricular process, and discussed next steps

- a. If an advisor has safety concerns based on the supervisory needs of the club and/or a significant increase in student participation and believes that an additional advisor is necessary, they should speak to their principal to request an additional advisor.

6. Rochester Labor Council Representation:

PDTA is still looking for an additional advisor to sit on this council.

7. PLC Advisory Committee:

Melanie and Stephanie are working to fill this committee. Building representatives and principals have made recommendations for members. Meetings will be from 8-11 the mornings of ILC. There will be a half-day release for those sitting on the committee. This committee will be looking into the future of PLC work in the district.

8. SRP Recognition Day:

Staff members will be given an “I support SRPs” sticker, provided by PDTA. Executive committee discussed the use of member dues to supply a gift to the SRPs in the district.

9. Student Debt Clinics:

PDTA can host our own Student Debt Clinic like those being offered across the region. This clinic has been highly recommended by our Resolution Specialist, Kim Chesko. It is free for PDTA to host, and is free for any NYSUT member to attend. Executive committee was in support of hosting this clinic.

10. NYSUT regional offices:

Executive committee discussed the benefits and drawbacks of using the NYSUT regional offices for our October meeting.
